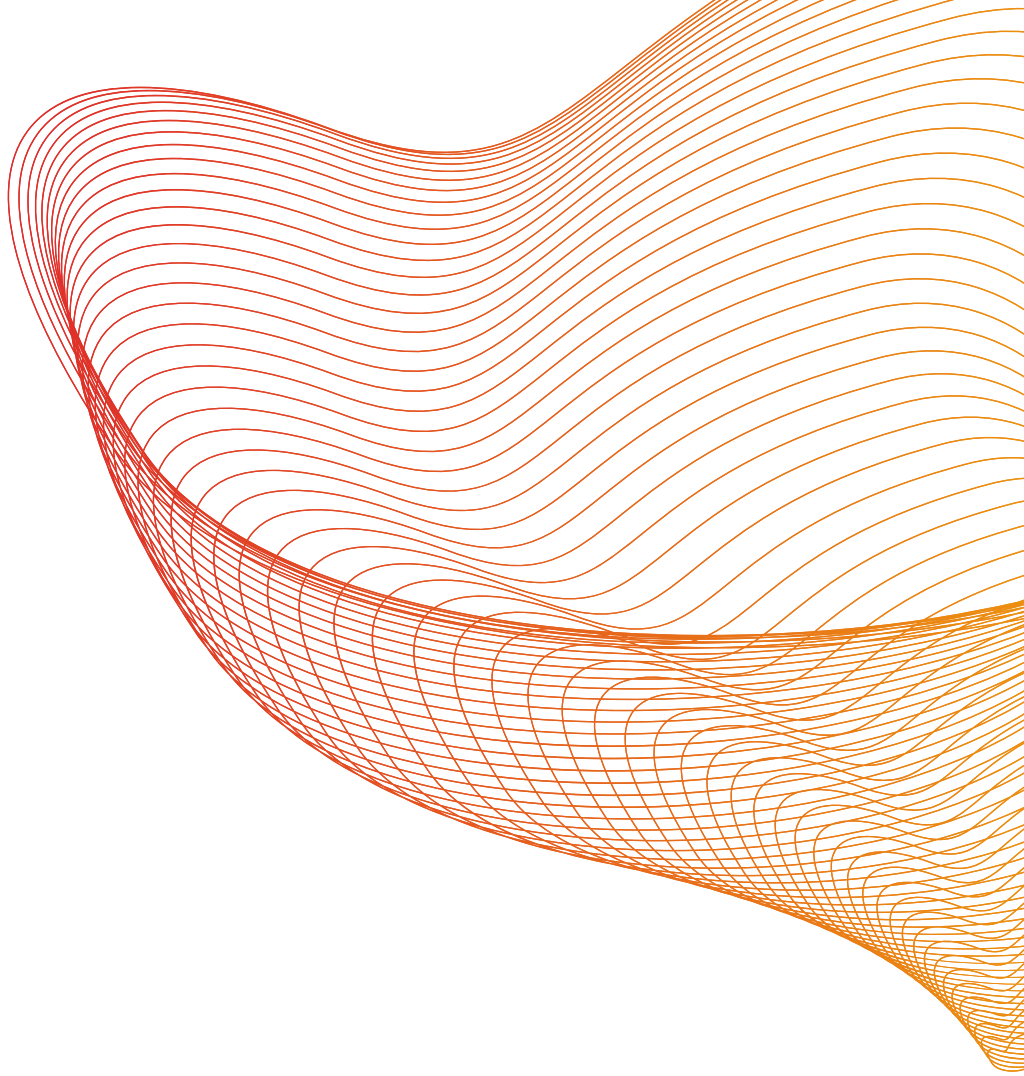

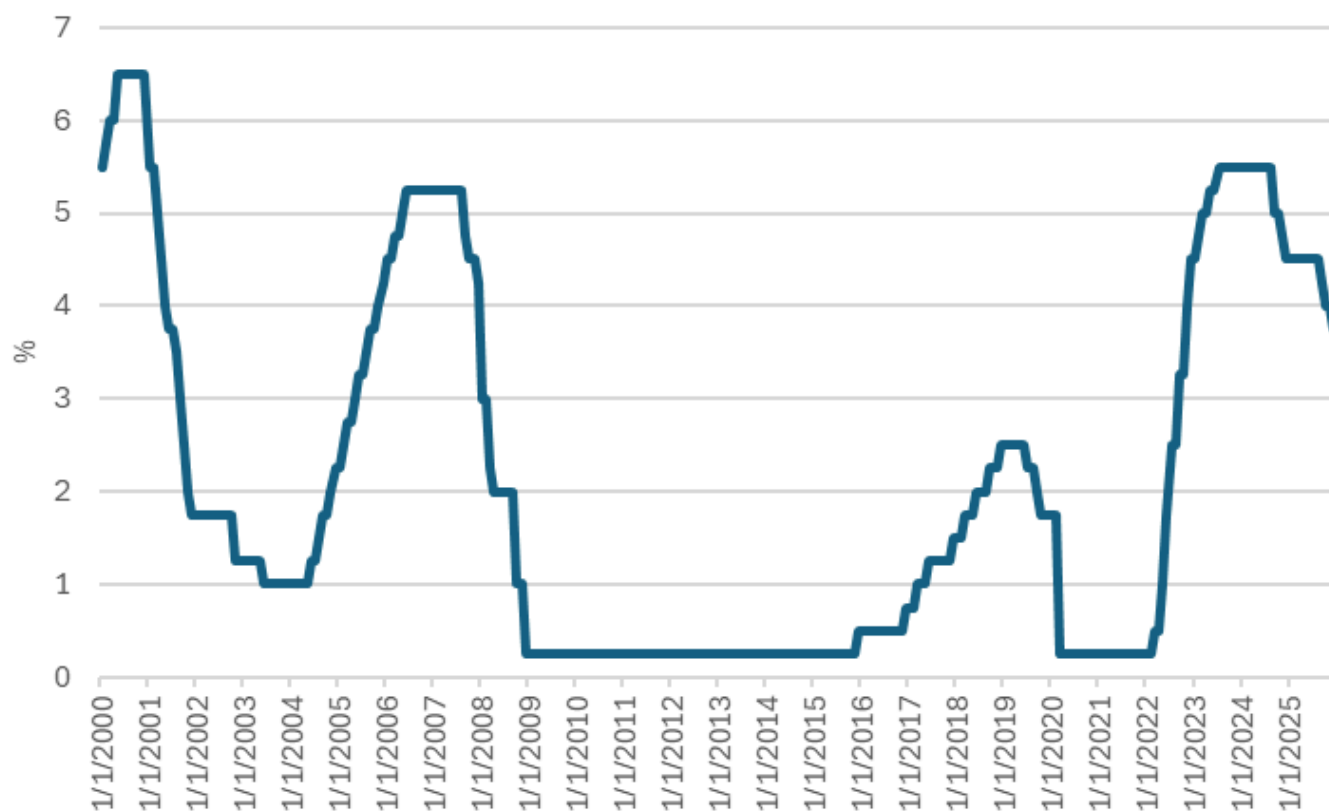

The Fed eased again in December

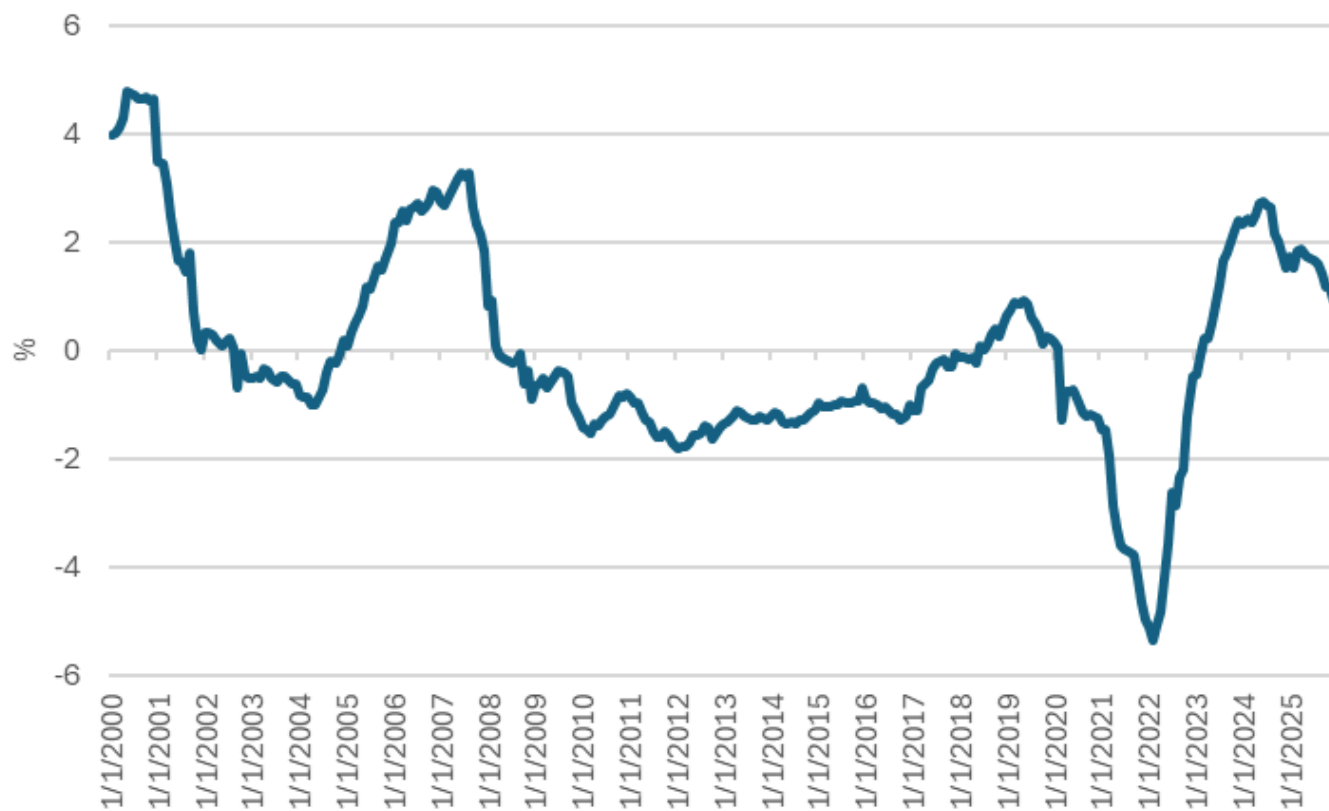
The federal funds target

Real rates are still elevated

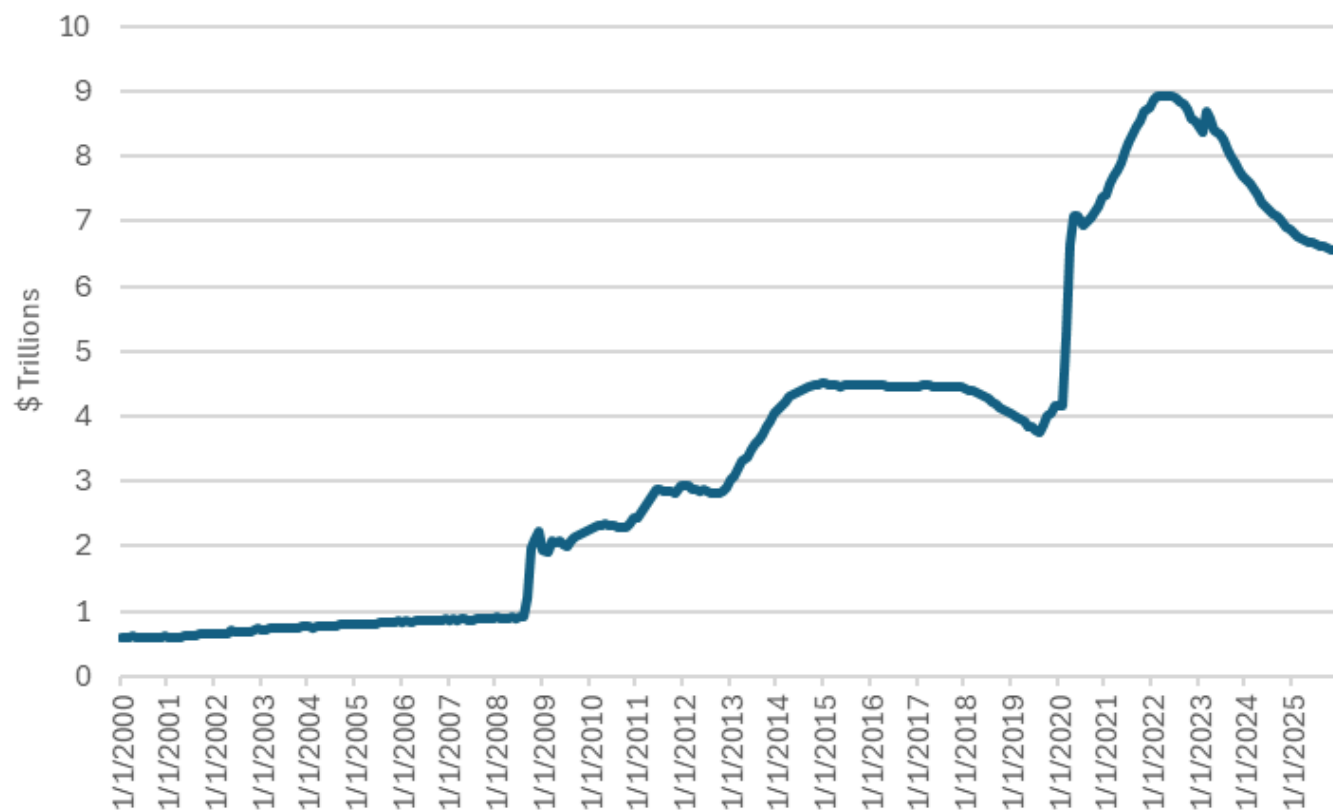
The real federal funds target

The Fed has ended its QT program

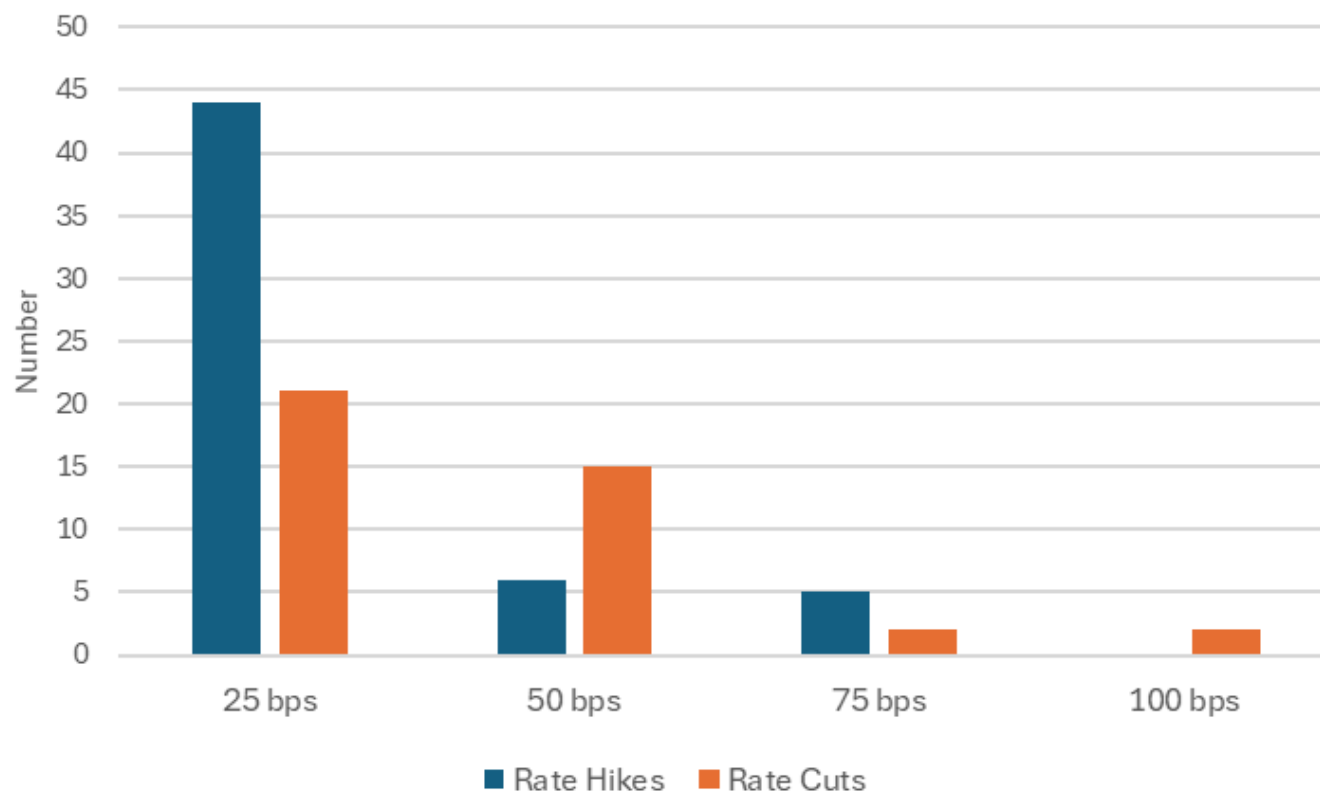
Assets on the Federal Reserve balance sheet

Rate cuts are often aggressive

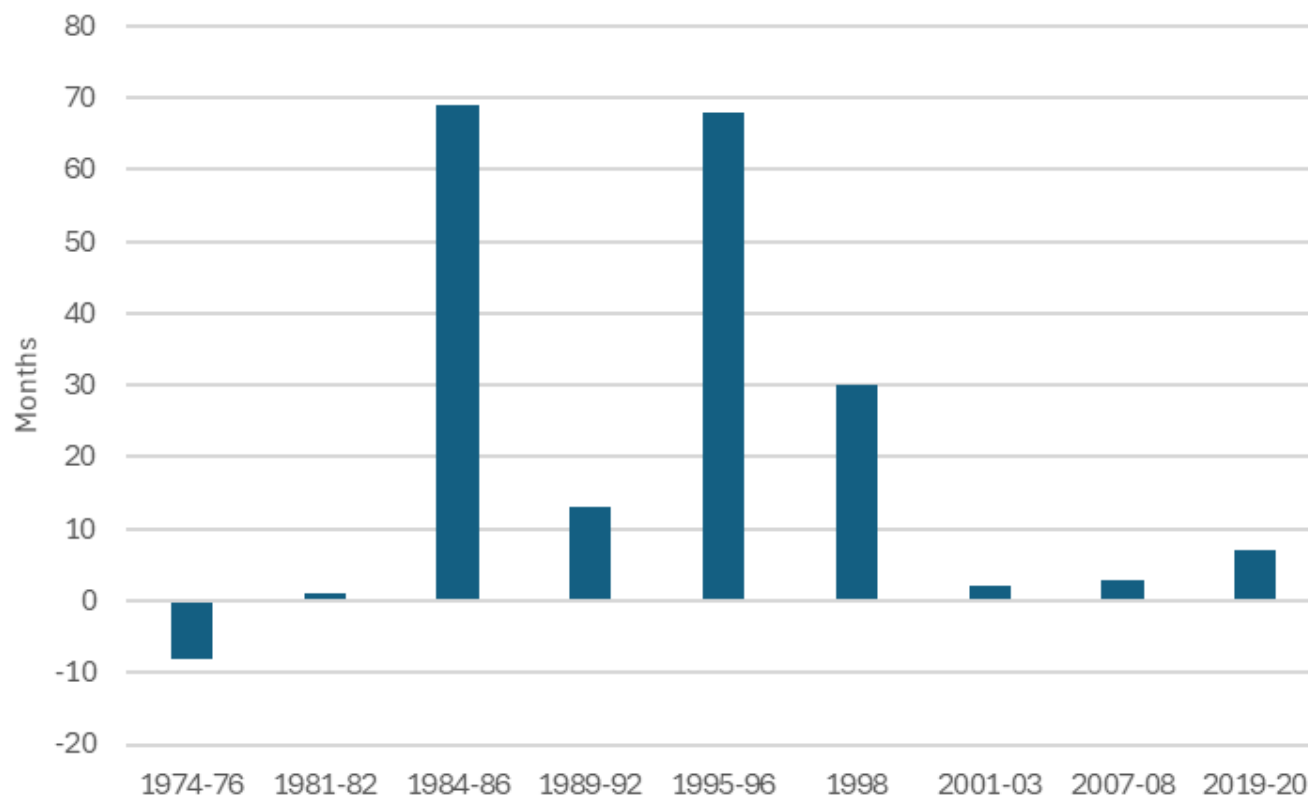
Changes in the federal funds target by magnitude, 1994-present

The Fed generally begins cutting rates prior to recessions

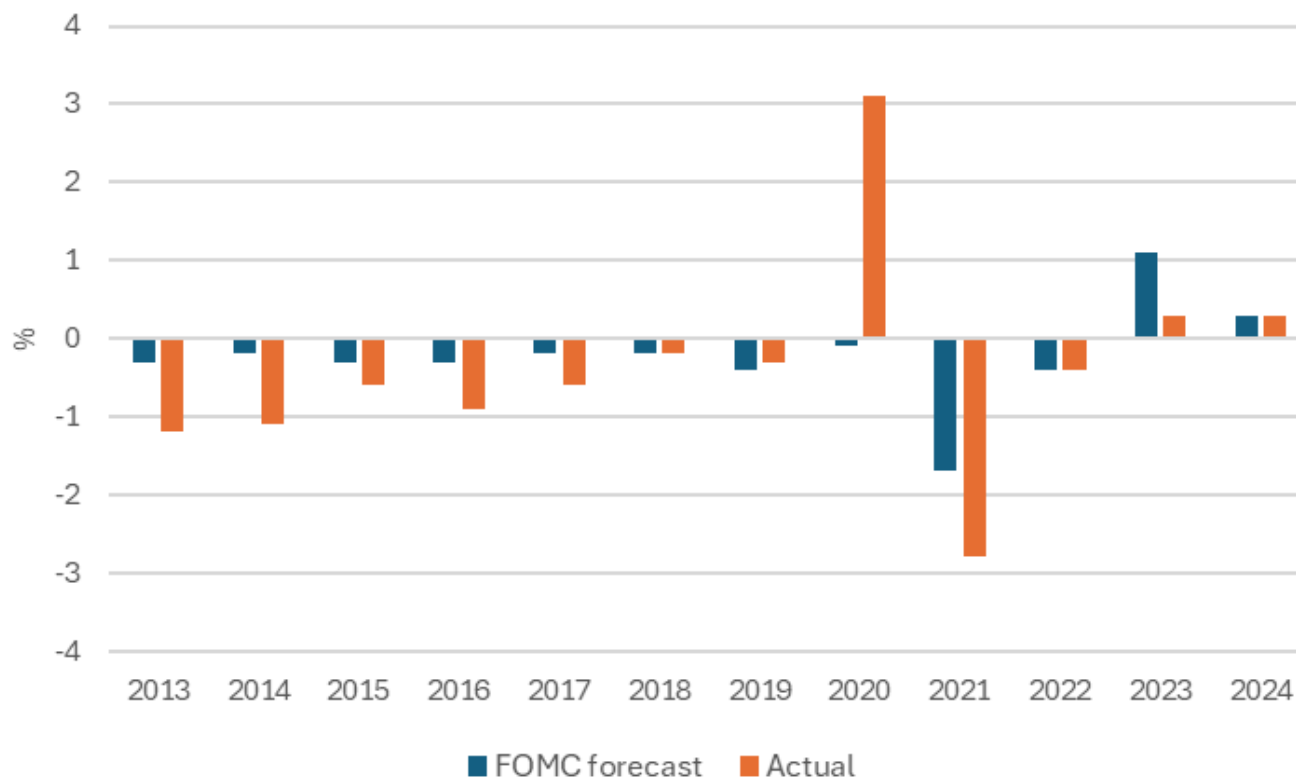
Lag between the first rate cut of Fed easing cycles and the outset of recessions

The Fed generally underestimates labor market changes

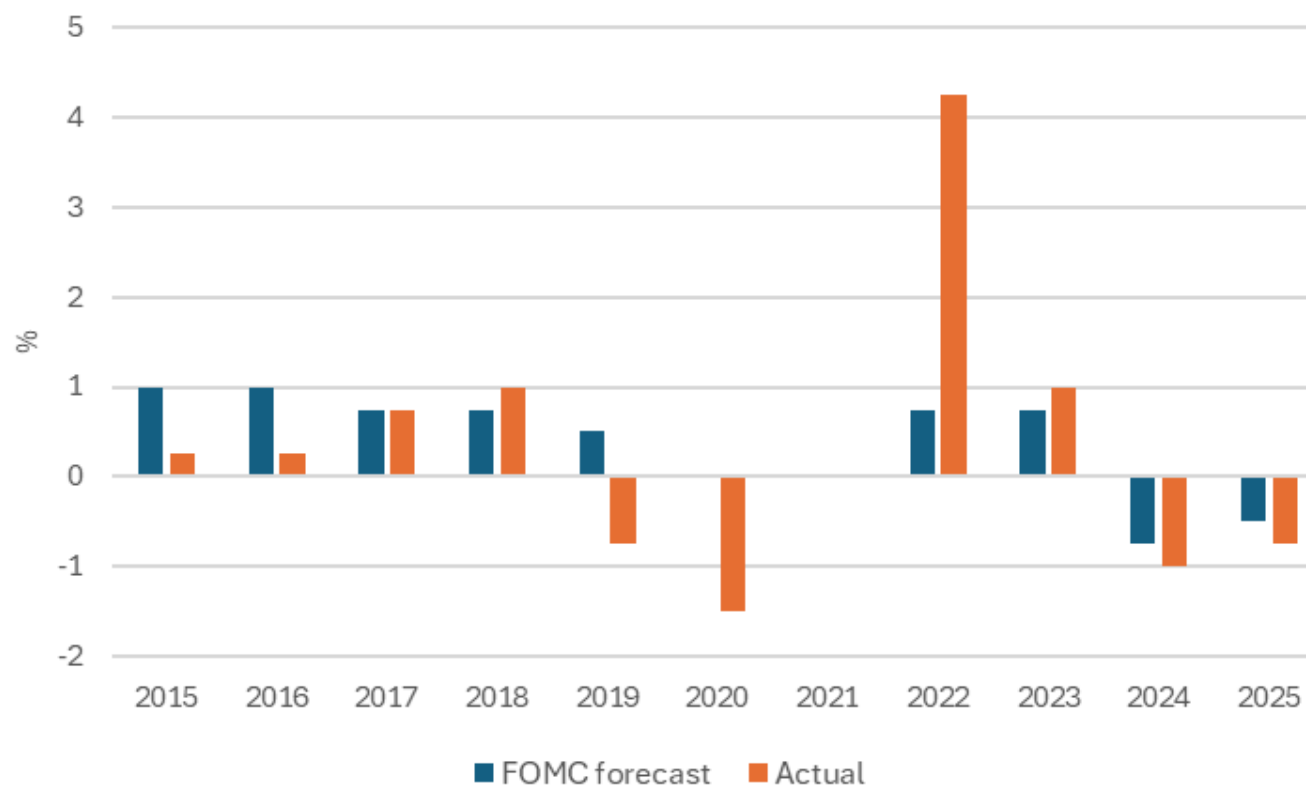
Yearly changes in the unemployment rate

Fed policy forecasts are often well off the mark

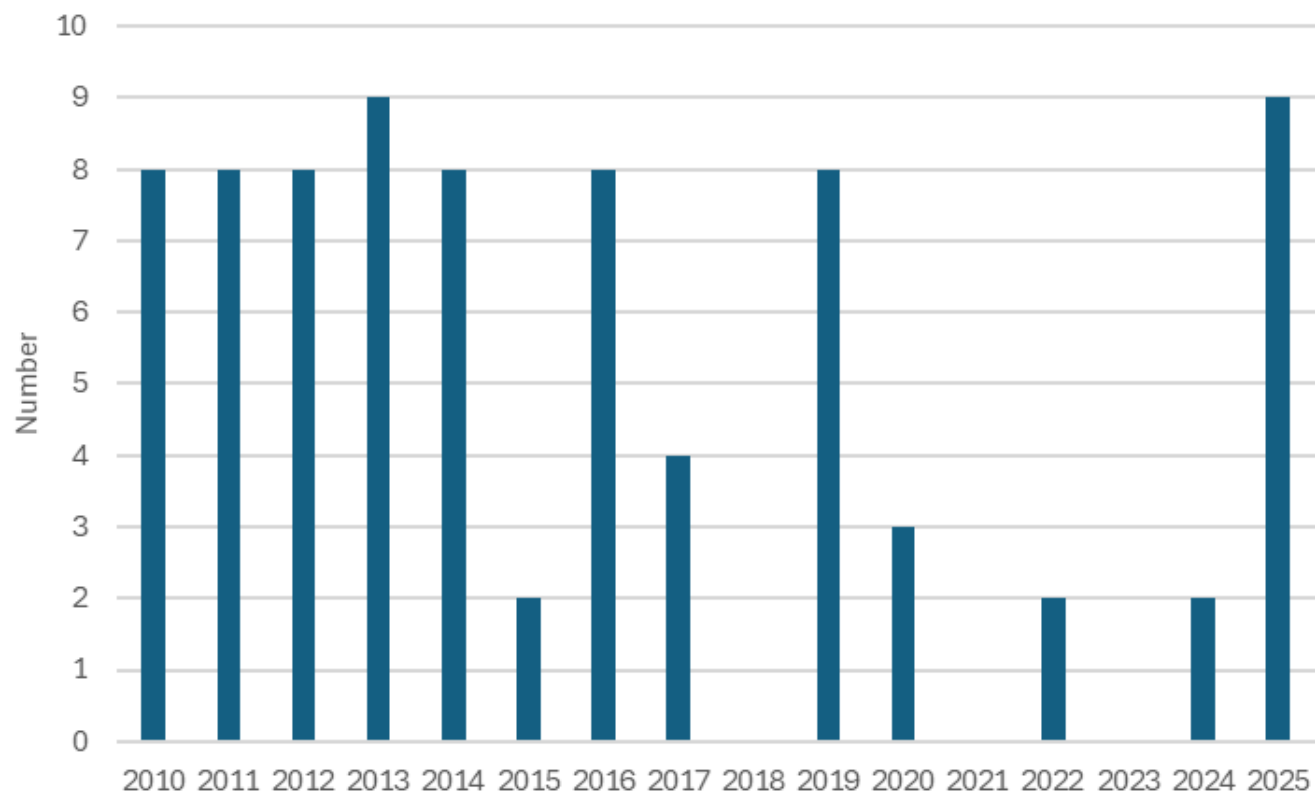
Yearly changes in the federal funds target

Fed officials have been less aligned this year

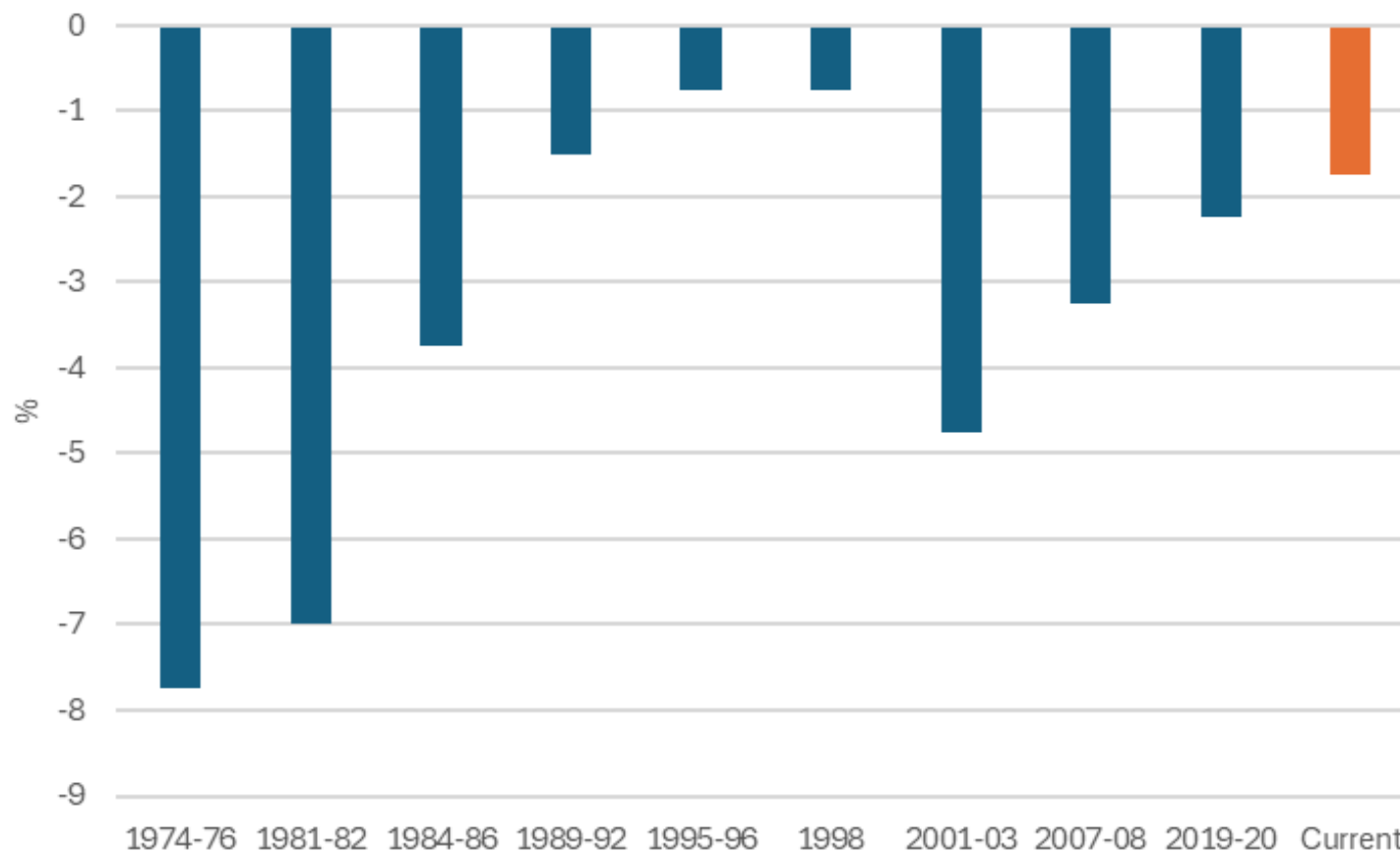
Dissenting votes cast at FOMC meetings
